1. Introduction

The Urban Co-operative Bank Ltd No.1758, Perinthalmanna invites sealed tenders from eligible and reputed vendors/suppliers for the supply, installation, and commissioning of ATM Machines as per the required specifications.

2. Scope of Work

The tender covers:

- Integration with the Bank's CBS and Switch provider.
- Testing, training, and handover.

- The bidder must have valid GST registration and PAN.
